## Warning!

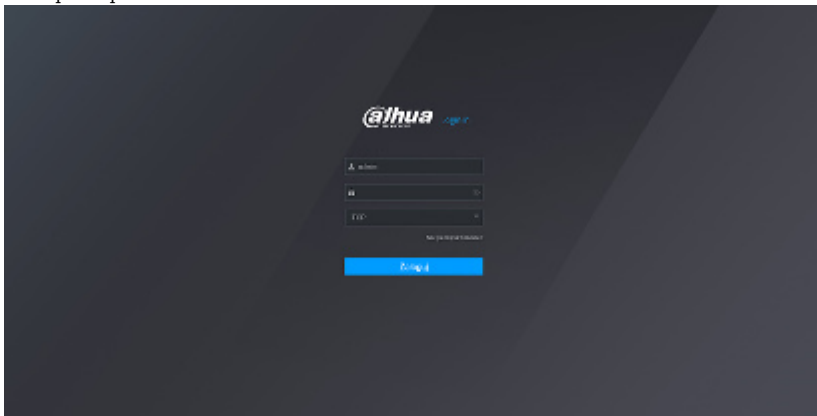
