Construction enables high level of tamper protection (against opening and removing from mounting surface).

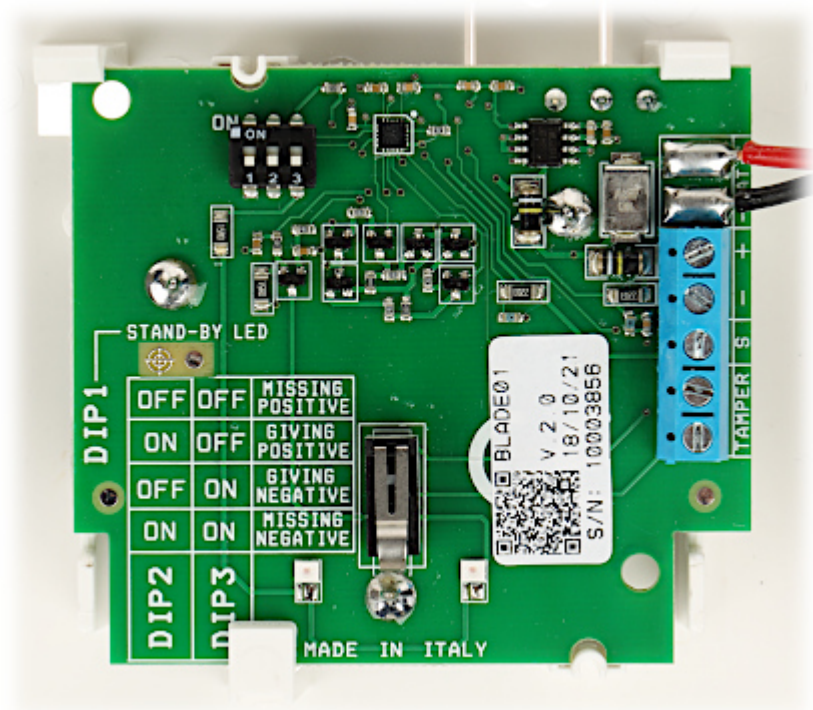
Front view:



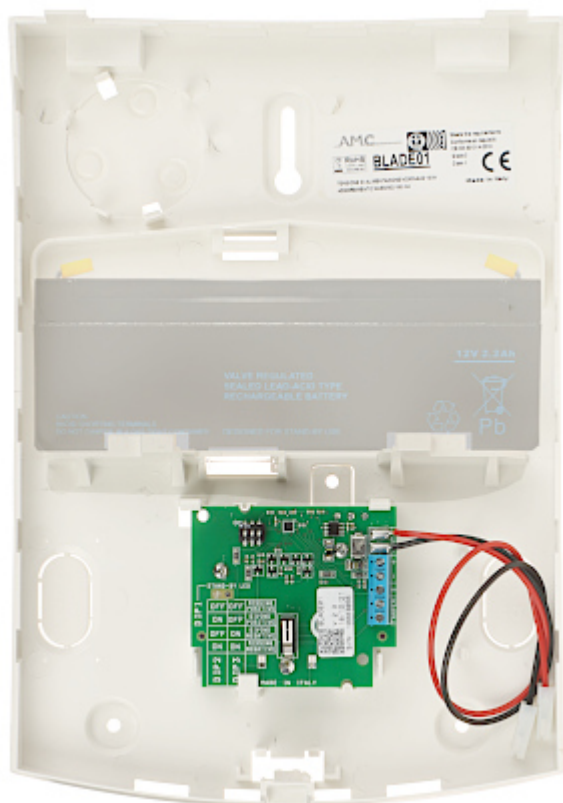
Mounting side view:
