Example applications: electric cars, campers, scooters, electric boats, wheelchairs, lawn mowers, photovoltaic installations, UPS, alarm and fire protection systems, access control and monitoring systems, etc.



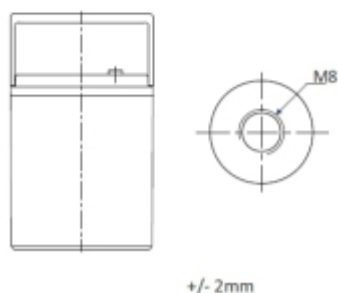
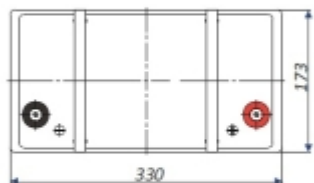
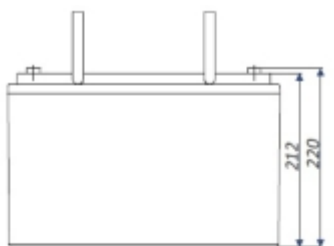
