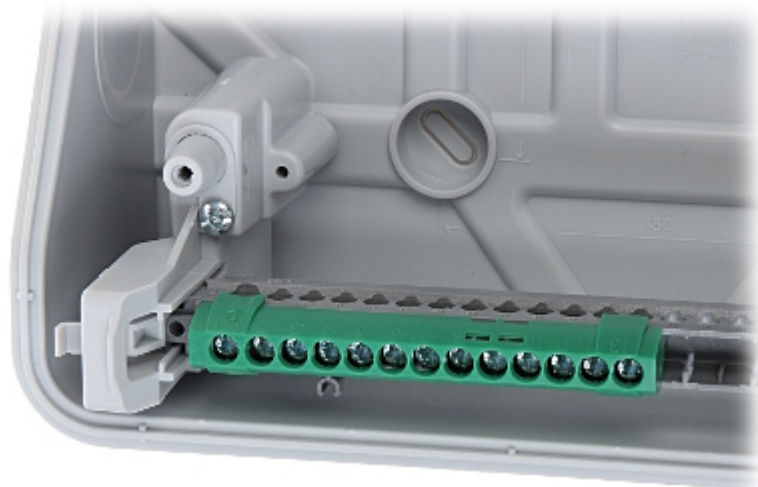
Front view:





Internal view of the housing:





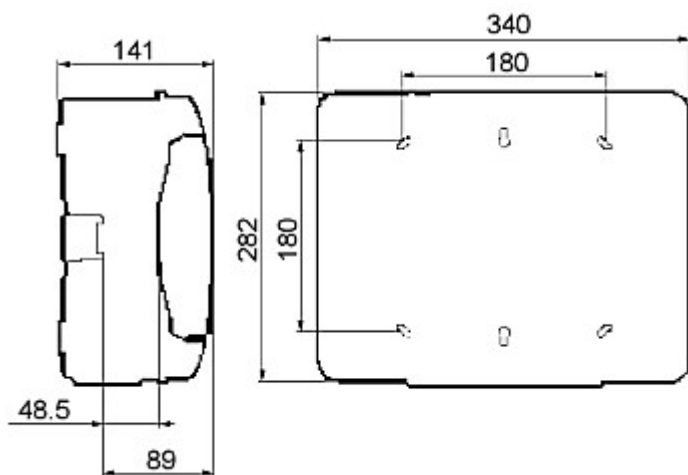

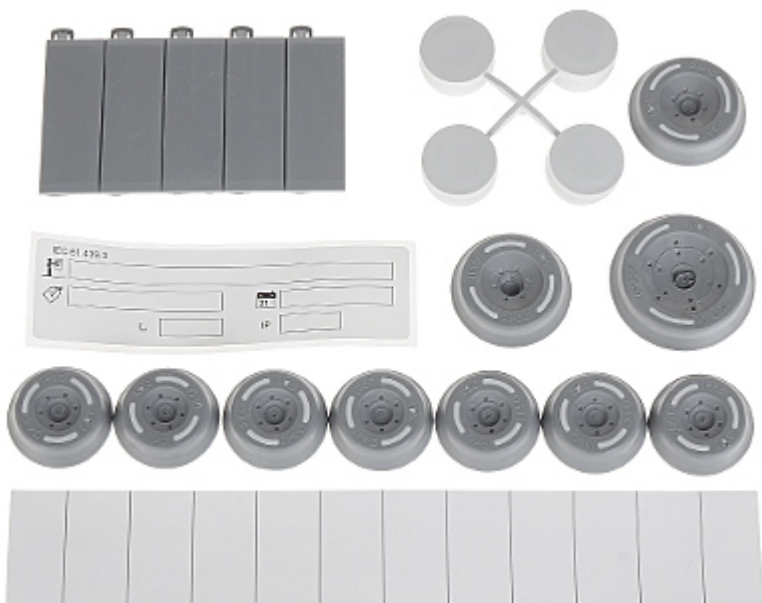
