The device must be secured against contact with caustic, staining and viscous fluids.



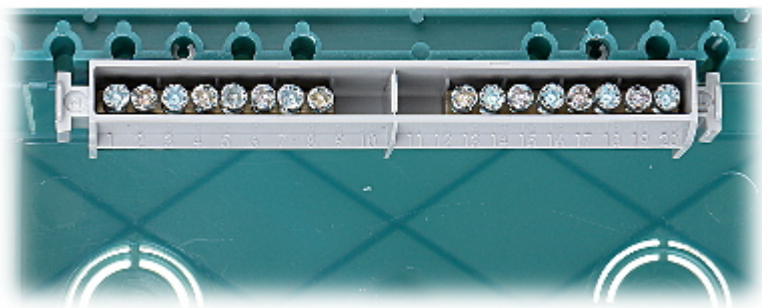
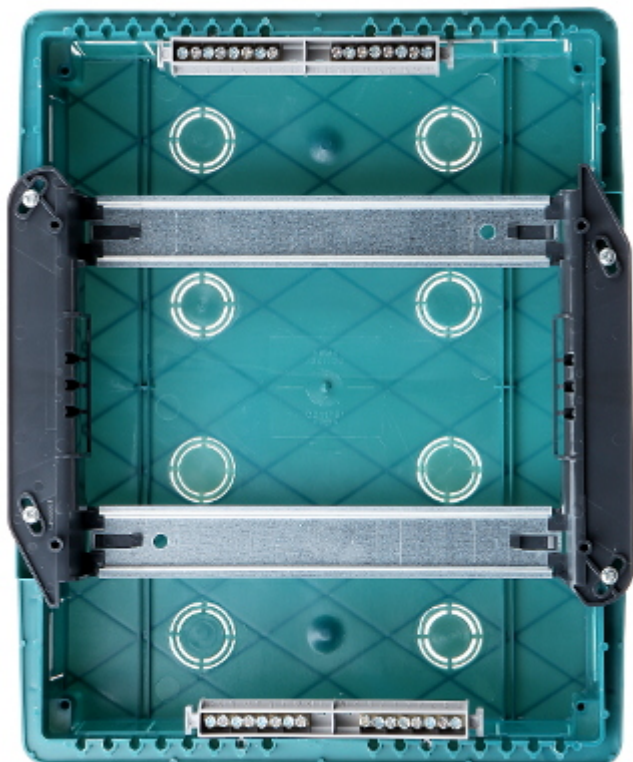

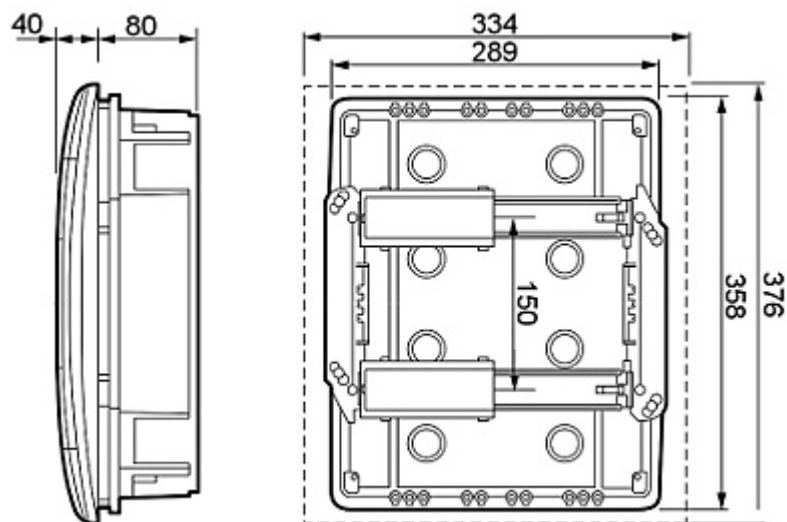
