The AHD / HD-CVI / HD-TVI interface allows to transmission of analog video signal via coaxial cable in max. 8 Mpx (4K UHD) resolution. During transmission there are no delays and is maintained the original, high quality image.

In the case of video transmission using a twisted pair cable and matching transformers (balun), be aware of the possibility of signal reflections and interfering signals. The range of IR illumination according to the manufacturer data, depends on outer conditions (visibility - air transparency, environment, wall colors ie. scene reflectance). Camera is according to IP67 Index of Protection norm.



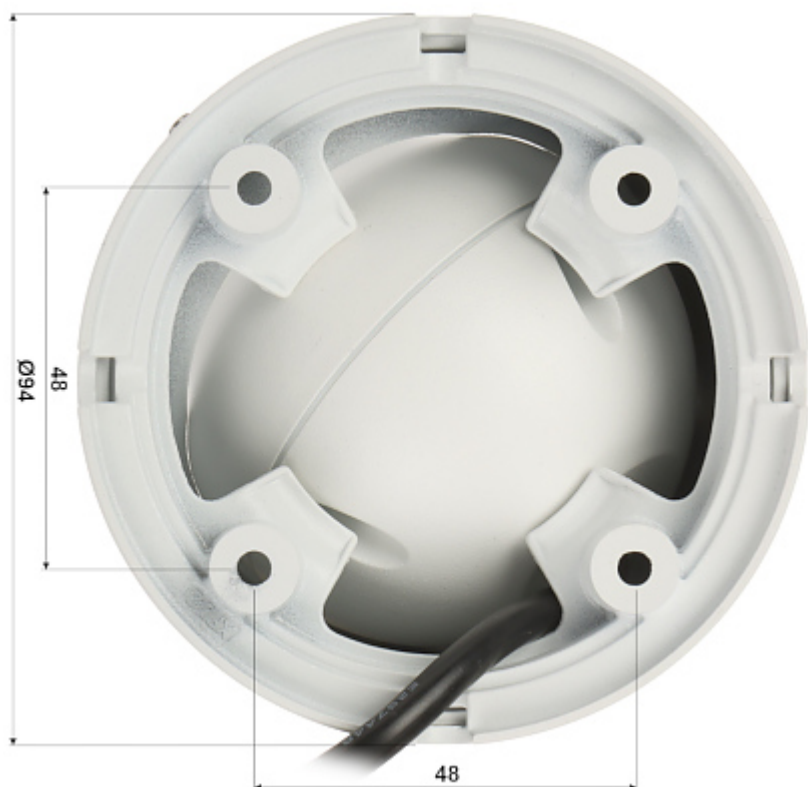

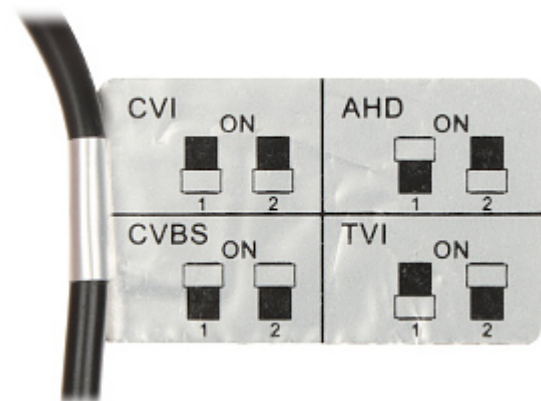
Internal view of the housing:
