In this way you will ensure yourself safety and avoid causing damage to the device.

The manufacturer and the supplier are not liable for losses or damages arising out of the product, including financial or intangible losses, loss of profits, income, data, pleasure from use of the product or other products related with it - indirect, incidental or consequential loss or damage. #### **Safety measures:**

Attention! We recommend using protections to further protect the device from possible overvoltages in installations. Surge protectors are effective protection against accidental pass to the device voltages higher than the rated. Damages caused by pass the voltages higher than specified in manual, are not under warranty.

#### Proper product disposal:
