The RG-RAP1201 access point broadcasts 2 separate wireless networks in the 5 GHz band with speed 867 Mb/s and in the 2.4 GHz band with speed 400 Mb/s. Simple tasks such as sending emails or web browsing can be handled by the 2.4 GHz band while bandwidth intensive tasks like online gaming or HD video streaming can be processed by the 5 GHz band – all at the same time.
