If you need good quality image from camera equipped with PINHOLE lens, we can recommend this camera model for you.



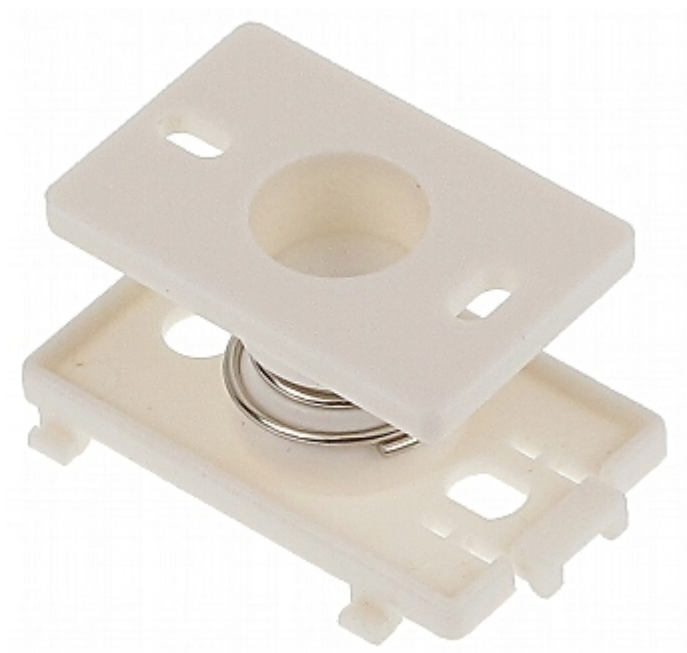
