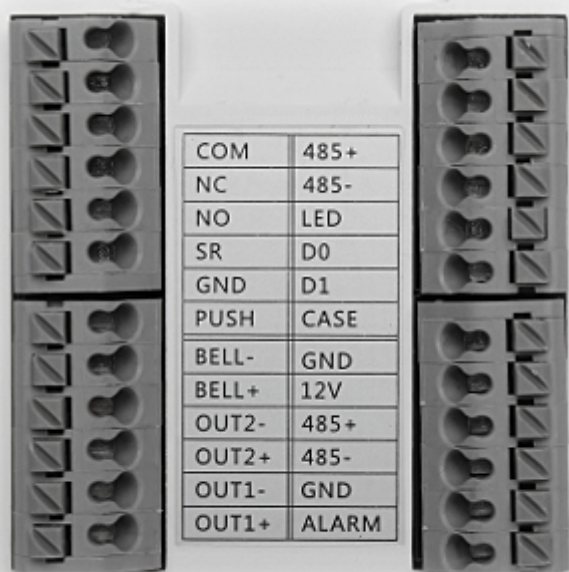

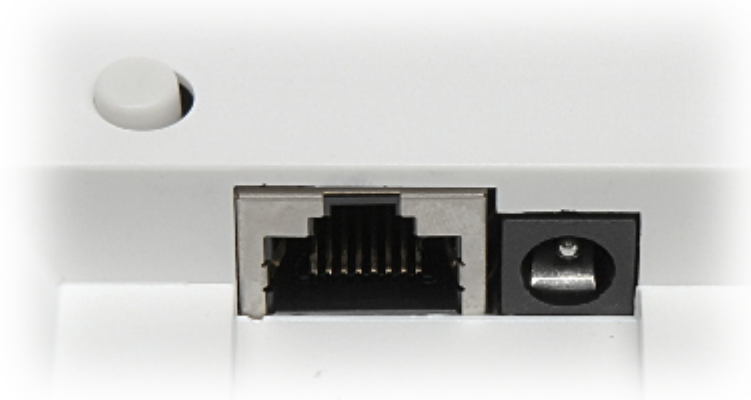


Mounting side view:

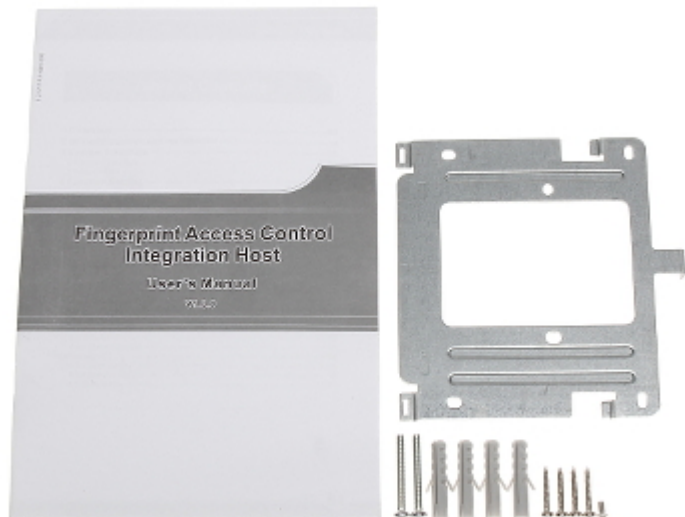
